<b>Course Description</b>	This course provides practical information regarding ethics and offers real-life examples to guide ethical decision making by practicing nurses.	This course teaches nurses about ensuring patient safety, safeguarding patient privacy, and helps nurses maintain “professional boundaries” with patients to avoid boundary crossing or violations. It also reviews social media use in healthcare settings and avoiding disclosures that violate privacy and confidentiality.

<b>State Board for Nursing Comments</b>	This course addresses misconduct involving unethical behavior by any nurse. It is especially suitable for LPNs.	This course is best for nurses who have provided unsafe patient care, violated patient privacy, had inappropriate personal relationships with patients, engaged in abuse or sexual misconduct, took inappropriate pictures of patients, or misused a patient’s assets. It is suitable for all nurses.
